## • Workshop: Understanding the Objective-Based Code

We're unable to offer this in our traditional workshop format. We're currently exploring how to present the workshop online, either as a webinar or as a downloadable, prerecorded workshop. We'll send you information about how to register for this workshop in a future email.

When this workshop is offered, you'll learn about the effective use of the objective-based code. You'll learn how to use the function, objective and intent statements, as well as the attribution tables. You'll understand how this information can help you with better interpretations and with providing alternative solution submissions to local authorities.
