Re: SBOA Exam Program

On January 26<sup>th</sup>, 2017, members of the SBOA Board of Directors met with Government Relations' Deputy Minister, Assistant Deputy Minister, and Chief Building Official to present a new path for building officials in Saskatchewan to become Certified, and an alternative path to achieve the Government of Saskatchewan Building Official Licenses. I am happy to report today that after four years of work, effort, collaboration, and partnerships from volunteers and industry professionals not only in this province, but from across the county, Building Officials in Saskatchewan have a new path to achieve our professional goals of becoming a licensed Building Official and advancing in our careers.

The SBOA Certification Exam Program is live. Mr. Meickel, Chief Building Official, Government Relations, through their due diligence and ongoing review of the development of the program, are prepared to accept successful achievement of the new SBOA exams as an acceptable alternative of the existing government licensing challenge exams. In addition, The Building Code Training for Canadians will also remain as a qualification option for a Class 1 licence. The government is approaching this as a 1-year trial basis in order to ensure the program serves its purpose effectively, and that any challenges or improvements can be handled efficiently.

Attached you will find a flowchart designed to help you navigate the process. The Southeast College, through a new agreement is the registrar for the new exam program. Similar to arrangements for writing BCTC or Government challenge exams, you will make your arrangements with an Exam Writing Location (many of which are still open – contact info will be on the website). Feedback is instant, and your marks will be held in permanent record with the College. We are putting together a new page on the website to make this process clear and outline how SBOA Certification plays into the new program. We are also putting together a new Syllabus to help outline each exam. There is a Syllabus available on the website now along with all our Certification Program information at <a href="https://sboa.sk.ca/about/policies-procedures-manual/">https://sboa.sk.ca/about/policies-procedures-manual/</a>. An SBOA Certification Application Form is attached as well.

Below is a brief outline of the exam program; exams are 2 hours, 50 questions, \$225 per exam:

## SBOA Building Official Code Qualified 3 / Building Official Class 3 License (alternative to the BSL-Class III Challenge Exam):

Exam 6 – Large Health and Safety 2015

Exam 7 - Large Classification and Construction 2015

Exam 8 – Large Plan Review – 2015

Exam 9 – Large Life Safety Systems – 2015

Exam 10 – Large Fire Protection - 2015

Footnote: the exams are being considered as alternative to the Challenge Exams; all other Licensing requisites and pre-requisites have not changed.

We promised our members and government that we would get this done.
